The following Quality Assurance (QA) applies to all Purchase Orders and Contracts, unless otherwise noted

Quality Clauses	
I 04 1	Any delay in shipment for any reason has to be conveyed to customer quality as soon as the delay is known by the supplier
QA 2	Any change to the contract requirements by the supplier must be approved by the customer in writing.
QA 3	All information in the contract must be held in confidence by the supplier and no third party request for information will be authorized unless instructed in writing by customer representative. All documents to be retained for 10-year min unless extended retention is required by customer quality flowdown. After the retention period the supplier agrees to either return or destroy any and all related documents.
	In addition to our right of access, the supplier agrees to right of access for our customers, or regulatory agencies to all facilities and records in the performance of this contract.
	Subcontractors are required to notify quality prior to transferring any work to a new facility. Customer will determine prior to the transfer if subcontractor may perform the transfer of work.
QA 6	Supplier notification to organization of nonconforming product.
QA 7	Arrangements for organization approval of supplier nonconforming material.
	Requirements for the supplier to flow down to sub-tier suppliers the applicable requirements in the purchasing documents, including key characteristics where required and positive FOD control processes
04.0	Requirement for supplier personnel awareness 1- their contribution to product or service conformity; 2— their contribution to product safety; 3— the importance of ethical behavior.

Processing suppliers must furnish processing certifications to the purchase order requirements, and shall not process any parts for which they are not certificated or approved. Nadcap / and or specification owner approval is required. Acceptable quality system requirement are AC7004 or ISO9001, or AS9100 any revision. QA 1, QA 2, QA 3, QA 4, QA 5, QA 6, QA 7, QA 8, QA 9 For Chemical suppliers, the following are the minimum requirements. The following are the minimum Requirements & Counterfit Must Comply to AS5553 Chemical suppliers must furnish material certifications to the purchase order requirements, and shall not supply

chemical suppliers must rurnish material certifications to the purchase order requirements, and shall not supply chemical for which they are not certificated or approved. When noted on our purchase orders, chemical supplied must be USA domestic material.

For Calibration/ Testing suppliers, the following are the minimum requirements

Calibration/test suppliers must furnish calibration/test reports to the purchase order requirements, and be traceable to the specific

equipment or item for which they are calibrating or testing traceability to NIST and/or other national or QA 12 international standards must be

supplied ISO9001, ISO 17025, Nadcap testing, ANSI z540, and/or Navlap accreditation will be the quality system requirements.

Actual data must be supplied. QA 3, QA 4, QA 5, QA 6, QA 8, QA 9, QA 12

All suppliers must comply with QA1- QA9. Additional Quality clauses will be noted on the Purchase Order as applicable.
